ORP Details

Orpea SA provides long-term health care services. It operates nursing homes, post-acute and rehabilitation care facilities, and general psychiatric clinics. The company's care facilities for the elderly provide care and support services to the residents; and logistical and residential services, such as accommodation, meals, laundry, room cleaning, and various entertainment activities. Its post-acute and rehabilitation care facilities offer physical medicine and physical therapy; orthopaedic and trauma rehabilitation; haematology and oncology post-acute and rehabilitation care; geriatric post-acute and rehabilitation care; and other specialist services, such as care of

chronic neurovegetative states and medical services. The company's psychiatric clinics provide services for the patients with acute mental pathologies, such as depression, obsessive compulsive disorders, eating disorders, and multiform neuroses and psychoses. As of March 2010, it had 28,073 beds at 300 sites in Europe, including 22,556 beds in operation and 5,517 under construction. Orpea SA also owns land and properties; and holds property finance lease. The company was founded in 1989 and is headquartered in Puteaux, France.

Groupe ORPEA reported sales results for the fourth quarter and year ended December 31, 2010. For the quarter, the company reported total sales of €250 million compared to €222.3 million for the same period last year. For the year, the company reported total sales of €964.2 million compared to €843.3 million for the same period last year. In 2010, ORPEA again recorded particularly buoyant sales growth. The Group has seen an improvement in each of its countries and across every business line with growth of 14.3%. This performance was the result of a virtuous combination of solid organic growth +8.7% and profitable external growth. The Group will open in the 12 next months 2,100 beds, of which 1,250 by the end of 2011. The company provided sales guidance for the year 2011. ORPEA is therefore particularly confident in its ability to achieve sales of at least €1,210 million in 2011, an increase of more than 25%.
